The Hampshire Heritage Fest committee extends an invitation to you and your organization to participate as a **Non-Juried** Arts/Crafts vendor in the annual Hampshire Heritage Fest, to be held on September 7-9 in Romney, West Virginia.

Please read the terms of participation carefully, fill in the form completely and legibly, and mail with your payment to the address indicated.

Terms of Participation. Read Carefully

1. The deadline for Arts & Crafts applications is **July 1**. We will begin reviewing applications and assigning spaces on July 2. Applications will be reviewed in the order that they are received.
2. The Arts & Crafts show will be held (where) High Street and Main Street.
3. Spaces are 10ft. by 15ft. The cost for all spaces is **\$50.00**.
4. The committee has final word on vendor space applications, however we will make every effort to honor individual requests.
5. Vendors must setup on Friday, September 7th, **after 5 p.m. and not later than 7 p.m.** OR on Saturday, September 8th, **between 7 a.m. and 9 a.m.** Vendors must supply their own tables, chairs, and power cords if needed. **Electricity is available for an additional \$ 25.00 fee.** Electricity is limited, so you may need to supply your own generator.
6. Each booth must be manned during show hours by the applicant or their designated representative.
7. The festival will not be held liable for any damages, loss or theft.
8. Breakdown is on Sunday afternoon at **3 p.m.**. No one is allowed to breakdown before then.
9. Type of ware/displayed must be consistent with the description set forth on the application. The decision of the committee is FINAL. If your entry is accepted, you will receive a receipt for fees, an acceptance letter, a list of motels/RV parks, restaurants, and a town map.
10. The committee reserves the right to reject any application for any reason.
11. Anyone trying to sell unacceptable products will be asked to remove those items from the show. Vendors who refuse to do so will be asked to leave immediately.
12. Unacceptable items include but are not limited to pornographic materials (T-shirts, pictures, literature, etc., poppers, any type of laser pointers or lights, loud noise makers, fireworks, silly string, hair color aerosol, alcoholic beverages, illegal drugs, drug paraphernalia, aerosol foul odor spray, or anything of vulgar or obscene nature.

13. The committee will not allow any type of abuse, including verbal abuse against any HHF member or volunteer. Anyone using profane language will be asked to leave. The use of any form of alcohol or illegal substances is prohibited.
14. No raffles are allowed unless approved by the HHF committee prior to the festival.
